Subject: Schedule for Admission in Class 9th to 12th under Rule-134-A of Haryana School Education Rules, 2003 amended in 2013.

In continuation of Directorate of Elementary Education Haryana, Panchkula letter no. 33/1-2017 PS (E-1) dated 15.03.2019 the schedule for admission to students belonging to EWS and BPL categories in class 9th to 12th (except 11th class) in private recognized schools under Rule-134-A of Haryana School Education Rules, 2003 amended in 2013 for the academic session i.e. 2019-20, vide letter under reference is hereby issued. However, it is clarified that the private recognized schools shall charge fee from these students on the same rate as is being charged in Govt. Schools.

Schedule for Admission in Class 9th to 12th under Rule 134-A of Haryana School Education Rules, 2003, amended in 2013.

- (i) Advertisement regarding admission in private recognized schools for EWS and BPL category seats will be published in leading newspapers latest by **19.03.2019**
- (ii) Publication of District and Block Level Committees by **20.03.2019**.
- (iii) Display of vacancies for the year 2019-20 by the private recognized schools on the notice board and school website by **25.03.2019**
- (iv) Date of application – **28.03.2019 to 04.04.2019**. Applications can be made online/offline.
- (v) Publication of list of eligible applicants by BEO/ BEEO by **05.04.2019**.
- (vi) Date of conducting assessment test to be held on **07.04.2019**.
- (vii) Declaration of result conducted **11.04.2019**.
- (viii) First draw of lots at Block Level on **12.04.2019**.
- (ix) Admission on the basis of draw of lots **15.04.2019 & 19.04.2019**.
- (x) 2nd draw of lots for remaining seats, if any, on **20.04.2019**.
- (xi) Admission on the basis of 2nd draw of lots **22.04.2019 to 25.04.2019**.
- (xii) If seats remain vacant even after 2nd round, concerned schools will submit their lists to the Concerned District Level Committee by **26.04.2019**.



Note:- The process of admission in Class 11th will be started after the declaration of result of 10th class.

Grievances Redressal Mechanism:-

Schools failing to comply with the provisions of Rule 134-A of Haryana School Education Rules 2003, amended in 2013 shall be subjected to withdrawal of recognition by the Department under the relevant rules on recommendations of the District Level Committee. Any aggrieved person can submit his/her complaint either before District Level Committees or Block Level Committee. It must be ensured that the above instructions are complied with in letter and spirit by the private schools.
