Schools and aided Private Schools 28 March, 2019.

Schedule for admission in class 2^{nd} to 8^{th} under Rule 134-A of Haryana School Education Rules, 2003, amended in 2013.

- (i) Publication of Advertisement of admission in private recognize school for EWS and BPL category by 18 March, 2019.
- (ii) Publication of District and Block Level Committee by 20 March, 2019.
- (iii) Display of Vacancies for the year 2019-20 by the private recognized schools on Notice Board and school website by 25 March, 2019.
- (iv) Date of receipt of applications in concerned <u>BEOs and BEEOs</u> offices from 28 March, 2019 to 04 April, 2019.

- (v) Publication of list of eligible applicants by BEO/BEEO on **05 April**, **2019**.
- (vi) Date of conducting assessment test to be held on 07 April, 2019.
- (vii) Declaration of result conducted 11 April, 2019.
- (viii) First draw of lots at Block Level on 12 April, 2019.
- (ix) Admission on the basis of draw of lots 15 April, 2019 to 19 April, 2019.
- (x) Second draw of lots for remaining seats, if any on 20 April, 2019.
- (xi) Admission on the basis of draw of lots 22 April, 2019 to 25 April, 2019.
- (xii) If seats remain vacant even after second round, concerned schools will submit their lists to District Level Committee by 26 April, 2019.

Schools failing to comply with the provisions of Rule 134-A of Haryana School Education Rules 2003, amended in 2013 shall be subjected to withdrawal of recognition by the Department under the relevant rules on recommendations of the District Level Committee. Any aggrieved person can submit his/her complaint either before District Level Committees or Block Level Committee. It must be ensured that the above instructions are complied with in letter and spirit by the private schools.
