**Subject:- Improving further the pay structure of Haryana Government Employees.**

Whereas pay scales of the State Government employees were revised w.e.f. 01.01.2016 vide Haryana Government Notification No.1/20/2016-5PR (FD) dated 28<sup>th</sup> October, 2016.

The matter has been further considered by the Government at length. After careful consideration, the Government has decided to modify the pay structure of certain categories of Government employees. Accordingly, in exercise of the power vested under the provision of Rule-17 Haryana Civil Service(Revised Pay) Rules, 2016 and all other powers enabling the Government so to do, the pay structure of the following categories of Government employees is hereby revised/modified as under:-

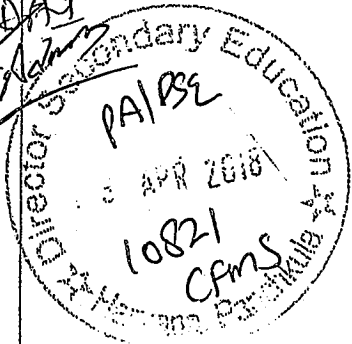
