Grant of reservation to Economically Backward Persons belonging to General Category in Jobs under Government/ Government Undertakings & Local Bodies as well as in admission in Government/ Government aided educational/ technical/ Professional institutions.

Sir Madam,

I am directed to invite your attention to the Government Letter No. 22/10/2013-1GSIII dated 21/27.02.2018 on the subject noted above vide which in context of Welfare of Scheduled Caste/Backward Classes Department notification No. 733W (1) -2013 dated 27.09.2013 the Hon'ble High Court in CWP No. 18514 of 2016 titled as Kalindi Vashishtha Vs. State of Haryana has directed that the impugned notification be not given effect to in respect of admission/Government job.

Now, keeping in view High Court order dated 18.5.2018 in CM No.3905 of 2018 in CWP No.18514 of 2016, State Government has decided to proceed to complete the selection and appointment process in respect of all cases where the selection process was notified prior to 07.12.2017. Concerned Departments/ Boards/ Corporations are directed to grant appointments to candidates selected under the EBPG category in all cases where selection process was notified prior to 07.12.2017. However, a specific condition shall be included in their appointment letters that the said appointment would be subject to the outcome of the proceeding pending before the Hon'ble Supreme Court in the appeal filed by the State of Gujrat on a similar issue.
