**Subject:- Matter regarding Haryana Subordinate Accounts Service (SAS) officers
of the Finance Department.**

Kindly refer to Finance Department's letter Memo No. 14/38/2015 - 5FA

dated 03.08.2015 on the subject noted above.

2. The Haryana Subordinate Accounts Service (SAS) cadre officers (Chief
Accounts Officers/ Senior Accounts Officer/ Accounts Officer/ Section Officer) are
posted in the Government Departments/ Public enterprises/ Autonomous institutions by
Finance Department to facilitate enforcement of financial discipline. In spite of earlier
instructions, it has been observed that in some of the cases, departments/ institutions have
repatriated SAS Cadre officers unilaterally. This has created adverse impact on the
morale of the officers concerned as well as unnecessary problem for the Finance
Department in accommodating them in new posts or to keep them on compulsory
waiting.

3. In view of this, it was desired that in future no department/ institution will
repatriate or surrender SAS officers unilaterally. In case the work or behaviour of a
particular SAS officer is not up to the mark, the same may be brought to the notice of
Finance Department with full justification so that appropriate action is taken in the
matter. Decision of the Finance Department regarding transfer/ posting of SAS cadre
officers is final, which is to be followed scrupulously by the Departments/ Public
Enterprises/ Autonomous institutions.

4. It was further desired vide the earlier instructions, that since SAS cadre
officers are qualified and trained in accounts, their services should also be utilized for
preparation of development & welfare plan proposals and budgetary exercise of the
Departments/ Public enterprise/ Autonomous institutions.

5. These instructions are being reiterated for strict compliance by all
concerned.
