### TERMS & CONDITIONS:-

1. Their appointment is against purely temporary post, which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. Their services can be terminated without any notice, whenever there is no vacancy against which they can be retained.
2. If at any stage they desire to resign their posts they will be required to give one month's notice or forfeit in lieu thereof, their salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to them by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate their services for the reason other than that mentioned in clause (I) above.
3. They will be required to take the prescribed oath of allegiance to the constitution of India.
4. In case they are married, they will produce the following certificate to his/her Head of office:- "That he/she is not having more than one living spouse." In case they are unmarried, they shall have to furnish a declaration to the effect that each of these will not have more than one living spouse.
5. In case they are married, they will have to furnished a declaration to the Head of the Department that they have not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
6. They will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the persuing of higher studies.
7. They will be required to produce the original Educational documents and date of birth certificate before joining their duties of the said post.



8. They shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining their duties.
9. If they have not been vaccinated within last twelve months they should have get it done before reporting themselves for duty.
10. No TA/DA or joining time will be paid to them for joining this post.
11. They will remain on probation for a period of two years, from the date of their joining in the department. The period of probation can be extended in accordance with the existing rule on the subject. For assessing their performance during the period of probation, their work conduct will be taken into consideration. If their work and conduct during this period is not found satisfactory their services will be terminated without any notice.
12. Their appointment is subject to have passed Matriculation or its equivalent examination with Hindi.
13. Their services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Haryana Government as per Finance Department's notification dated 28.10.2005.
14. That in the matters, not specifically mentioned in this Communication, they shall be governed by the Civil Service Rules as applicable to Haryana Government employees and such rules/order /instructions as may be issued by the State Government from time to time. They shall further be governed by the "Haryana Education Directorate (Group-D) Rules, 1998" as amended from time to time.
15. His seniority amongst chowkidars/peons will be determined from the date he resume duty in the office.
16. The DESM/ESM category candidates will have to furnish a fresh eligibility certificate duly issued by Zila Sainik Board to the effect that he/she has not availed of the benefit of dependent of Ex-serviceman and has not availed any other benefit in any manner.
17. That if they got appointment on the basis of furnishing false/forged or fraudulent information/facts/documents which are detected later on to be false or forged or fraudulent, they would be liable for termination of their services without any notice besides such criminal action that may be taken as prescribed in the Indian Penal Code or any other Law enforce.



18. That in case of reserved Category candidates, their appointment is subject to the verification of their domicile and castes certificate.
19. These appointments are subject to the final outcome of CWP No. 307683/2018, 30376/2018, 23769/2018, 31085/2018, 32246/2018, 24327/2018, 23801/2018, 26478/2018, 37683/2018, 22969/2018, 331/2018 etc. and any others writ petition pending in the Hon'ble High Court and any other Court of law.

If the above terms and conditions are acceptable to them, they should report for duty to the office mentioned above within 15 days of the receipt of this communication along with relevant documents as stated above failing which the offer will be cancelled.
