**Subject: Extension of one year to private schools for fulfilling the norms as prescribed in the Haryana School Education, Rules, 2003.**


Kindly refer to the subject noted above.

In this regard it is stated that the District Level Committees constituted under the Chairmanship of concerned Deputy Commissioner was authorized to finalize the cases of permanent recognition under the provisions of Haryana School Education, (amended) Rules, 2009 which were notified on 21-2-2009. Deputy Commissioner is competent authority to grant permanent recognition to the schools under the aforesaid rules. Apart from this a notice was also issued in the year 2007-2008 to the un-recognized private schools directing therein not to admit the students in their schools. This notice was challenged by the un-recognized private schools by way of various writ petitions which are still pending in the Hon'ble High Court. The Hon'ble Court was pleased to stay the operation of the notice issued by the Directorate. Now the academic session 2011-12 has started and the cases of permanent recognition are still pending in all the Districts of the State. Till the cases of permanent recognition are not finalized by the District Level Committees., it will be appropriate to allow further one year extension to comply with the norms as prescribed in the Haryana Schools Education Rules 2003 and amended rules, 2007 for the current academic session 2011-12 and also to allow provisional affiliation with haryana Board of School Education, Bhiwani for the categories of schools given below:--

1. All schools having provisional affiliation with Haryana Board of School Education Bhiwani or temporarily recognized by the school Education Department and allowed by the Haryana Board of School Education Bhiwani last year on provisional basis.

2 Schools in respect of whom applications (received on or before 10-4-07) are pending with the Department/District Level Committee of Deputy Commissioners for grant of permanent recognition. The Department shall dispose off the pending applications in a time bound manner.

It has also been decided that no school will be allowed to run as un-recognized school from the next academic session 2012-13 starting from 1-4-2012 and any act contrary to the provisions of the rules will invite appropriate action under the rules.
