**Terms & Conditions:**

1. If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
2. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the CS office instructions dated 31.05.2006, without issuing any notice.
3. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
4. If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centres located outside the campuses of the University, without seeking approval of UGC and the State Government, then such candidate shall be



reverted in view of Division Bench judgment of Punjab and Haryana High Court in CWP no. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.

5. If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the 'Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
6. In the case of candidates whose inter se seniority as PGT/ Lecturer is not available in the database, then such candidates will be suitably placed by determining their inter se seniority as PGT/ Lecturer and will be assigned subsequent seniority in the corresponding Principal seniority list accordingly.
7. If subsequently any senior person becomes eligible for promotion due to availability of ACRs or other records, then in that eventuality, he/she shall be treated as senior to any promoted junior candidate, even if promoted later.
8. After joining at the station allotted herein he shall proceed on a School Leadership training to be imparted through *Teacher Education Institutions* controlled by the SCERT, Haryana. The detail programme in this respect shall be communicated to his by the SCERT, Haryana.
9. The District Education Officer concerned shall ensure compliance of above conditions before letting the promoted Principal to join.
10. Needless to say, the present promotion is subject to the outcome of any court case pending in any court of law which might have any bearing on the present order.
